Once again this year, we have been given a great opportunity to perform for the Rosemount Community. Saturday night, November 17th is the annual City of Rosemount Tree Lighting Ceremony. (You may recall that last year it was located at the Rosemount Community Center because the RHS band was performing and leaving for the Macy's Thanksgiving Day Parade in NYC.) This year the event will be back on the front steps of the Steeple Center (14375 S. Robert Trail - our old church building on Hwy.3). We will be singing at 6:00 p.m. outdoors prior to the tree lighting. There will not be transportation from the school before or after the performance. Families are responsible for getting your student to the Steeple Center by 5:45 p.m. on that evening. Parking is available in the library parking lot and across Highway 3.

Because this is not on the school calendar as an official event, it is optional but necessary that I hear back from families to get a commitment and head count for logistical purposes. There will be no large rehearsal at the school or at the Steeple Center. We will be singing three songs (two from our upcoming Christmas concert and "Jingle Bells"). Because it is an outdoor event there is no specific dress code and students are encouraged to dress warm (jeans, snow pants, winter coats, hats, mittens, boots, etc.).

Following our portion of the event there will be complimentary cookies, hot chocolate and photos with Santa in the Community Room while RHS musical groups perform. If you're new to the St. Joseph Community, it's a great time to tour our old church, now attached to a new senior housing complex.
